

## Childcare Taskforce - Teen Parent Advisory Pilot \*\*\*\*\* Invitation to Participate \*\*\*\*\*

The Alignment Nashville Childcare Taskforce subcommittee is leading a community-wide effort to pilot a **Teen Parent Advisory** at one or more high schools in the Metropolitan Nashville Public School (MNPS) district that will *educate and support pregnant and parenting teens*. This pilot advisory seeks to increase the number of students applying for childcare certificates, advance student knowledge of available resources in the community, and improve graduation and post secondary education rates at the pilot site(s). The pilot advisory will meet at least monthly during the already established 30-minute advisory period and will engage community organizations to provide much-needed information on topics identified by the participating students. The pilot school site(s) will be determined by MNPS administrators during summer 2010.

The committee invites organizations to participate in the Teen Parent Advisory during the 2010-11 school year by making interactive, engaging presentations on topics of interest to parenting teens, including:

- College admissions/financial aid processes
- Childcare Certificates
- Home Visiting Programs
- WIC/Food Security Programs
- Parenting Styles
- Intellectual Development of Children
- Normative Child Development

- Nutrition
- Lifetime Wellness
- Personal Finance
- Job Opportunities
- Affordable, Quality Child Care
- Additional topics that may be of interest to this population of students

If your organization would like to participate, please respond to this Invitation to Participate (ITP) by June 25, 2010. The committee will review all responses for appropriateness and relevance to the target audience on June 28, 2010\*. \*Note: All participating organizations must be approved through an MNPS FLSE review.

The committee will then hold a review and planning session on Wednesday, July 7, 2010 (time and location TBA) to allow committee members, MNPS personnel, and students to preview presentations and collaborate with community organizations to develop a comprehensive program schedule for the 2010-11 school year that covers all of the topics requested by students and teachers at the pilot site(s).

Review/Planning Session: July 12, 2010 -- the committee asks that each organization presentation be reviewed by the committee members and students from the spring 2010 Teen Parent Advisory program for feedback and placement in the program schedule.
